- 3. In the case of temporary absence, withdrawal or removal from the school or any of its services, I am still obliged to pay all applicable fees.
- 4. I further understand that: a) If the tuition fee is outstanding for more than 15 days, the student will not be eligible to resume classes until the outstanding amount has been cleared. b) In the event that any school related fees, text books, library books or any other material belonging to Al-Ameen Elementary School are outstanding, report cards will not be issued until the outstanding account has been cleared.
- 5. I hereby grant permission for my child to be included in any pictures and/or video connected with the school program and promotion of the school.
- 6. I understand that Al-Ameen Elementary School does not have the resources or facilities to accommodate special needs students, gifted children and children with learning and physical disabilities.
- 7. I agree to assume all costs, responsibilities, liabilities and risks in connection with the child's enrollment as a student of Al-Ameen Elementary School including, without limitation, the child's use of play and sports equipment, and participation in school activities.
- 8. I hereby grant permission for my child to use all of the play equipment and to participate in all school activities.
- 9. I understand and agree that the school will not be responsible for anything that may happen as a result of false information given, or information withheld at the time of enrolment and any false information which may lead to my child's dismissal from the school.
- 10. I hereby grant permission for my child to use the Internet for academic purposes at school.
- 11. I understand that a probation period of three months will be applied for all new students.
- 12. I hereby grant permission for my child to ride a school bus and leave the school premises under the supervision of a staff member to participate in school trips. I understand that if my child is not participating in a school trip, he/she must stay home.
- 13. I am aware of the Al-Ameen educational programs and activities that my child will be participating in as a student of Al-Ameen Elementary School.
- 14. I have read, understood and agree to comply and follow the policies and procedures as stated in the Al-Ameen Elementary School Parental Handbook found on the schools website.
